**Guideline notes for media accreditation applications for

Accreditation Guidelines:

- The applicant must be part of the editorial team, or on an assignment for a specific publication, broadcast media outlet, or news service (print and/or digital). Freelance journalists will only be granted accreditation if they are representing a bona fide outlet.
- When considering application forms the Australian International Three Day Event Media Officer may request sample work.
- Press accreditation applications must be submitted by 15 October 2016. Please note any applications received after the closing date may not be considered.
- Only one Photographer per publication/outlet will be accredited for each day of the event.
- All sections must be correctly and completely filled in - incomplete forms will not be accepted. Previous accreditation is no guarantee of a repeat in 2016 or in the future.
- Only a limited number of press passes are available.

Authorisation and Waiver

The Holder may not broadcast, publicise or make commercial use of any visual or audio media of any kind of the 2016 AI3DE if it breaches any licensing contracts agreed to by the 2016 AI3DE unless such broadcast is agreed to by the AI3DE. The Holder recognises that he/she must immediately report the theft, loss or unauthorised use of the Accreditation Pass. Acceptance of an Accreditation Pass constitutes agreement by the Holder of the above conditions.
